MAGICAL SUMMER SWEEPSTAKES

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING DEPEND ON THE NUMBER OF ENTRIES RECEIVED. VOID WHERE PROHIBITED.

Please read these Official Rules carefully, as they contain important information about the rights and obligations, as well as limitations and exclusions that may apply, to participate in this Sweepstakes. By participating, each participant agrees to abide by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes.

- 1. **Sweepstakes Description**. The Magical Summer Sweepstakes (the "**Sweepstakes**") is Sponsored by TRCC/Rock Outlets, LLC, PO Box 1000, Lebec, Ca 93243 ("**Sponsor**"). Weekly drawings will occur as described herein.
- 2. **Sweepstakes Period.** The Sweepstakes begins at 12:00 a.m. Pacific Time on June 1, 2025, and ends at 5:00 p.m. Pacific Time on June 29, 2025 (the "**Sweepstakes Period**"). Entries submitted before or after the Sweepstakes Period will not be eligible. The Sponsor's computer runs the official clock for the Sweepstakes and will solely determine the time by which an entry is received.
- 3. **Eligibility**. The Sweepstakes is open only to legal residents of California who are eighteen (18) years of age or older, or the age of majority where participant resides, whichever is older, at the time of entry. Employees, officers, directors, agents, and representatives of the Sponsor, and any of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies, as well as all employees, staff, contractors, and individuals employed by or associated with any shop, kiosk, or business operating at the Outlets location, and the immediate family members (spouse, parents, siblings, and children) and household members (whether related or not) of each such individual (collectively the "**Excluded Entities**"), are not eligible to participate in or win the Sweepstakes.

All participants agree to be bound by these Official Rules and the decisions of the Sponsor which shall be final and legally binding in all respects. All participants hereby release Sponsor, the Excluded Entities, and each of their respective parents, affiliated companies subsidiaries, and all other businesses involved in this Sweepstakes, as well as the employees, officers, directors, shareholders, representatives, agents, successors and assigns of each, of the foregoing (collectively, the "Released Parties"), from all claims, liability, lawsuits, costs, expenses, fees, injuries (including death), losses, and damages relating to their participation, acceptance and use misuse of any prize. Winners assume all liability for any injury or damage, including death caused or claimed to be caused by participation in this Sweepstakes or use/misuse, or redemption of a prize. Winning a prize is contingent on fulfilling all requirements in these Official Rules.

4. **How to Enter. Maximum six (6) entries per person per calendar day, regardless of method of entry.** Entries received by any method are treated with *equal dignity*—each entry carries exactly the same odds of winning. All entries, whether in-person or mail-in, will be treated equally in the winner selection process. Non-winning entries from one weekly drawing will carry over to subsequent weekly drawings, provided the participant has not won a prize. Participants may only win once during the Sweepstakes Period.

- (a) **In-Person Entry Without Purchase (Limit 1 Per Day)**. During the Sweepstakes Period a participant may complete one (1) official entry form without providing a receipt by visiting the Guest Services office at The Outlets at Tejon ("**The Outlets**") during regular business hours (10:00 AM to 5:00 PM PT, Monday through Sunday) and completing an official entry form Participant must hand-print all required information legibly and deposit the form in the designated entry box. Limit one (1) no-purchase in-person entry per person per calendar day.
- (b) **Purchase Entry** (**Limit 5 Per Day**). After submitting the free in-person entry described above, a participant may earn up to five (5) additional entries that same calendar day by:
 - (i) Making a qualifying purchase at any retailer at The Outlets (any amount); and
 - (ii) Presenting the original, itemized receipt(s) at the Guest Services Office and completing a separate entry form for each receipt. One (1) eligible receipt = one (1) entry. Receipts must clearly show the store name, date, and purchase amount. Duplicated, altered, or illegible receipts are void.
- (c) **No Purchase Alternate Method of Entry (Limit 5 Per Day)**. In lieu of providing receipts for the additional five (5) daily entries, a participant may mail in free entries as follows:
 - (i) Hand-print your full name, complete mailing address, phone number, email address (if available), Instagram handle (if applicable), and the words "Magical Summer Sweepstakes Entry" on a plain 3x5-inch card.
 - (ii) Mail the card in a standard #10 envelope with sufficient postage to: Magical Summer Sweepstakes Entry, 5701 Outlets at Tejon Parkway, Suite 170, Tejon Ranch, CA 93203.

Each card received constitutes one (1) entry. Limit of five (5) mail-in entries per person per day, with each entry mailed in a separate envelope. Mail-in entries must be postmarked during the Sweepstakes Period and received before each drawing date to be eligible for that drawing, or before June 29, 2025, to be eligible for the final drawing. No photocopied, mechanically reproduced, or bulk entries will be accepted. Sponsor is not responsible for lost, late, misdirected, damaged, or incomplete mail-in entries. Entries submitted under this Section (c) are included in each drawing for which they are eligible and have the same chance to win as entries obtained via purchase.

5. **Entry Limits and Terms**. Each participant is limited to a total of six (6) entries per day, regardless of entry method. Entries exceeding this limit will be disqualified. Use of automated, programmed, or other methods to obtain multiple entries is prohibited and will result in disqualification. All entries become the property of the Sponsor and will not be returned. Sponsor reserves the right, in its sole discretion, to: (i) verify any element of any entry, related materials or participant's eligibility; (ii) to request more information; and (iii) to disqualify any Participant whose participation may subject the Sweepstakes, Sponsor or Sponsor's advertisers, clients, or customers to controversy, negative publicity, scorn, or ridicule. By entering this Sweepstakes, participant agrees to provide any documentation or information considered necessary by, and in a form acceptable to, Sponsor to satisfy the above requirement if asked by Sponsor to do so.

- 6. **Prizes**. Four (4) prizes will be awarded, one per weekly drawing. Each prize consists of one (1) \$1,000 Disney Gift Card (Approximate Retail Value ("ARV"): \$1,000). Total ARV of all prizes: \$4,000. Prizes are non-transferable, non-assignable, and no substitutions or cash equivalents are permitted, except at Sponsor's sole discretion. Winners are responsible for all federal, state, and local taxes associated with prize acceptance. Prizes will be awarded "as is" with no warranty or guarantee, express or implied, except for any manufacturer's warranty provided with the Disney Gift Card. Disney Gift Cards are subject to terms and conditions set by the issuer.
- 7. **Winner Selection and Odds**. Weekly drawings will be held on or about the following dates: June 9, 2025; June 16, 2025; June 23, 2025; and June 30, 2025. For each drawing, Sponsor will randomly select one (1) winner from all eligible entries received by the entry deadline for that drawing:
 - **June 9 Drawing**: Entries received from June 1, 2025, at 12:00 AM PT to June 8, 2025, at 5:00 PM PT (in-person) or postmarked and received by June 8, 2025 (mail-in).
 - **June 16 Drawing**: Entries received from June 1, 2025, at 12:00 AM PT to June 15, 2025, at 5:00 PM PT (in-person) or postmarked and received by June 15, 2025 (mail-in).
 - **June 23 Drawing**: Entries received from June 1, 2025, at 12:00 AM PT to June 22, 2025, at 5:00 PM PT (in-person) or postmarked and received by June 22, 2025 (mail-in).
 - **June 30 Drawing**: Entries received from June 1, 2025, at 12:00 AM PT to June 29, 2025, at 5:00 PM PT (in-person) or postmarked and received by June 29, 2025 (mail-in).

Non-winning entries from one weekly drawing will carry over to subsequent drawings, provided the participant has not won a prize. Odds of winning depend on the total number of eligible entries received for each drawing. All entries, whether in-person or mail-in, have an equal chance of winning, and no preference is given to any entry method. Participants may only win once during the Sweepstakes Period; if an entrant's name is drawn in a subsequent drawing, an alternate winner will be selected.

8. Winner Notification and Verification: Potential winners will be notified by the Sponsor in-person at the time of the Drawing or via e-mail and/or telephone, and participant may be required to provide an e-mail confirmation and/or telephone number within two (2) calendar days of the respective Drawing. The failure to respond to such notification or a potential winner's noncompliance with these Official Rules may result in disqualification, and at Sponsor's sole discretion, an alternate winner may be selected. If the selected winner is unable to accept a prize in its entirety for any reason, the selected winner will forfeit the prize and the prize will be awarded to an alternate winner from all eligible entries remaining in the relevant Drawing. Any winner of a prize or prizes valued at \$600 or more may be required to sign and return the following documentation: an Affidavit of Eligibility/Liability & Publicity Release, a Confidentiality Agreement, and a W-9 taxpayer identification form, within three (3) calendar days following the date of first attempted notification. Failure to comply within this time period may result in disqualification and selection of an alternate winner. In the event that any prize notification message is returned as undeliverable or if no response to the prize notification message is received within the time period stated or if the winner is found ineligible or does not comply with these Official Rules, the prize may, in the Sponsor's sole and absolute discretion, be forfeited and awarded to an alternate winner selected at random from among remaining eligible submissions. Any disputes arising under or related to the Sweepstakes shall be resolved in the state or federal courts located in Kern County, California.

As a strict condition of participating in the Sweepstakes, participant agrees: (a) to abide by these Official Rules and the decisions of Sponsor, which shall be final and legally binding in all respects; (b) to the use of their names and/or likenesses and/or biographical data by Sponsor and its designees for advertising, Sweepstakes and other purposes in any and all media now or hereafter known throughout the world In perpetuity from the conclusion of the Sweepstakes at discretion of Sponsor without compensation, permission or notification (except where prohibited by law); (c) THAT RELEASED PARTIES SHALL HAVE NO LIABILITY AND SHALL BE HELD HARMLESS FOR ANY DAMAGE. LOSS OR INJURY TO AN ENTRANT OR ANY THIRD PARTY RESULTING FROM PARTICIPATION IN THIS SWEEPSTAKES OR THE USE OR MISUSE OF ANY PRIZE. PRIZES ARE AWARDED "AS IS" WITHOUT ANY REPRESENTATIONS OR WARRANTIES EXCEPT FOR ANY "IN THE BOX" WARRANTY THAT MAY BE PROVIDED WITH A PRIZE; (d) UNDER NO CIRCUMSTANCES WILL ENTRANT BE PERMITTED TO OBTAIN AWARDS FOR, AND ENTRANT HEREBY WAIVES ALL RIGHTS TO CLAIM PUNITIVE, INCIDENTAL, CONSEQUENTIAL, OR ANY OTHER DAMAGES, OTHER THAN FOR ACTUAL OUT OF POCKET EXPENSES, IF ANY; (e) ALL CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THIS SWEEPSTAKES, OR ANY COMPENSATION OR CREDIT TO BE PROVIDED, SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; AND (f) ANY AND ALL CLAIMS, JUDGMENTS, AND AWARDS SHALL BE LIMITED TO ACTUAL OUT OF POCKET COSTS INCURRED. IF ANY, AND IN NO EVENT SHALL ENTRANT BE ENTITLED TO RECEIVE ATTORNEYS' FEES OR OTHER LEGAL COSTS OR EXPENSES.
- 11. Disclaimer. Released Parties are not responsible for lost, interrupted or unavailable network, server or other connections, miscommunications, failed phone, computer or telephone transmissions or technical failure, jumbled, scrambled or misdirected transmissions, errors related to participation in the Sweepstakes or other errors or problems of any kind whether typographical, printing, human, mechanical, computer, electronic or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or problems which may occur in connection with the administration of the Sweepstakes, the results of the Sweepstakes, the conduct of the drawings or the results of the random drawings, the incorrect submission of any Entry, the announcement of the prize or in any Sweepstakes-related materials or for any damage to your or any other person's computer hardware or software as a result of participation. Released Parties are not responsible for entries that are late, lost, stolen, incomplete, inaccurate, undelivered, misdirected, garbled or delayed.
